Article 1. Content of the investment project:

- 1. Name of investment project: QUASATHU LLC
- 2. Objective of the project:
- -To provide consultancy services for enterprises, to prepare business plans, to the feasibility of a project, to organize a business, to manage information, to manage projects (except consultancy on accountancy, audit) (CPC865)
- To provide advising service and engineering consulting for big projects (CPC 8672)
- 3. Size of the project:
- Area of using premises: 206m²
- Output products, services: Consultancy service, advising service and engineering consulting for big projects.
- 4. Location of the project: 7th Floor, ACB Building, 218 Bach Dang street, Phuoc Ninh ward, Hai Chau district, Da Nang city.

Article 3: Conditions on the investors of the project

- 1. The investors, business organization shall process to subscribe an account in the National information system on foreign investment in accordance with regulations of law.
- 2. On reports regulations, the investors, business organization of the investment project must:
 - Report monthly, quarterly annually to the Department of Planning and Investment of Da Nang City and the local statistics department the progress of executing the investment project, with contents: investment capital executed, result of investment activity, trading, information of labour, payment of the state budget, investment on research and development, treatment and protection of the environment and the specific norm of the operation industry; to perform the reports in writing and through the National information system on the foreign investment; to perform the unscheduled reports upon the request of the competent authorities.
 - Report every 06 month and yearly on the supervision and assessment of the investment to the Department of Planning and Investment of Da Nang City in accordance with regulations of the Decrees by the Government and Circulars by the Ministry of Planning and Investment.
 - Be responsible for the accuracy, righteous content of the reports and shall bear all consequences due to not to perform, to perform un-adequately the regular reports or reports the untruth. The investors, business organization of the project shall not be considered to adjust the Certificate of Investment registration, should they not perform the reports as regulated.
- 3. The investors, business organization of the project must perform properly the schedule of capital contribution, the schedule of the project commencement as registered and the content indicated in the Certificate of Investment registration.
- 4. Regarding to the location of the project:
 - When the lease term expires, the investors, business organization shall renew the lease with the Lessor in accordance with current applied laws, if the lease renewal is not available, it requires to move to other location, in compliance with the legal issue and the planning for performing the project, without any request for a compensation to the State of Vietnam.
 - In case the lease term expires, the investors, business organization cannot renew the lease of the location with the Lessor, and they cannot find other location, in compliance with the legal issue and the planning for performing the project, the Investment registration authority shall consider to end the operation of the project and

revoke the Certificate of investment registration prior to the term.

5. During the operation of the project, the investors, business organization of the project

shall comply with Vietnam laws, as below:

- Only to start the operation for the conditional industry upon the satisfaction all regulated conditions and being issued licenses of trading by speciality industry authorities, papers with equivalent value and /full business conditions in accordance with regulations of applied laws.

- To be responsible to apply measures and concrete plans to meet the requirements of fire prevention, fire-fighting, labour safety at the project location in accordance with regulations of

applied laws.

- To be responsible to comply with regulations of road traffic safety of Laws on road traffic and relating guiding writings, it requires to arrange and allocate reasonably parking areas for clients, for employees and to ensure not to transgress the street, pavement, causing traffic jam at the location of the project.
